## Small Arts Grants Are Available for Arts & Cultural Activities and Have Been Awarded to 3 Organizations

The Prairie Lakes Regional Arts Council has Arts grants available for Arts & Cultural Activities and BIPOC led Arts Initiatives in the 9-county area of southern Minnesota. The purpose of our Arts Grant is to provide funding for non-profit organizations directly engaged in the creation of art, the production of artistic performances or arts services, or the sponsorship of quality arts activities in our local communities. This may include dance, literature, media arts, music, theater, visual arts activities, and public art projects.

"Prairie Lakes is encouraging arts projects for cultural activities and underserved populations as identified in our PLRAC Diversity, Equity, and Inclusion Statement. This includes: BIPOC (Black, Indigenous and People of Color), Economically Disadvantaged, Youth, Senior Citizens, People with Disabilities and LGBTQ+," noted Brenda Byron, Executive Director.

The next Small Arts Grant deadlines are January 1, and February 1, 2021 and the Arts & Cultural Heritage Grant of \$6,000 is due on February 1, 2021. Applicants will now be allowed to receive more than one grant per fiscal year and projects must be completed within one year of the awarding of the grant. We are also pleased to announce that State arts grants of \$12,000 were awarded in December to three arts organizations. The Small Arts Project Grants are made possible by funds provided by the Minnesota State Legislature and can be awarded for up to \$4,000. No cash match is required. To create more flexibility for arts organizations and community groups to apply for a grant the Prairie Lakes board has increased the Small Arts Community Project Grant maximum from \$2,000 to \$4,000.

A variety of activities including **virtual events** and inperson events are being funded. Due to COVID-19 all organizations must plan for events that include social distancing and wearing masks; and they are required to follow the Governor's Stay Safe Plan and the MN Department of Health's recommendations. The three organizations that were awarded grants in December are:

2B Continued - \$4,000. They are a nonprofit organization that promotes mental health and wellness through community outreach. They will offer Free virtual dance lessons for community members 50 years and older living independently or in congregate housing settings, and also for families with school aged children, led by professional dance instructors (Danny Ross of Henderson RoadHaus and Andrea Mirenda of Heart of Dance). The virtual lessons will begin February 2021 and be coupled with mental wellness, including self-confidence, resilience and teamwork. Funds will be used for artist fees, publicity, and salary.

Davori Productions, Mankato Playhouse - \$4,000. They will produce two Broadway Teen productions and workshops for grades 6-12 in Mankato in Spring/Summer 2021. Students will gain knowledge, training, and experience in musical theater. Funds will be used for director and technician stipends, royalties, publicity, etc.

Open Arts Minnesota - \$4,000. Open Arts Minnesota provides inclusive theatrical and literary opportunities for people with disabilities. With this grant, they will offer virtual theatre and poetry workshops and rehearsals in Fairmont, New Ulm and Mankato/North Mankato and several other communities. Funds will be used for staff time and a website update. Funds will also be used to create a technology lending library with the purchase of Tablets. These Tablets will be lent to people who do not have access to such technology so they can participate in the activities. Virtual programming begins in Jan. 2021.







## Small Arts Project Grants Available at \$4,000

The Small Arts Community Project Grant has been increased to \$4,000 maximum and there is no cash match required.

The purpose of the Small Arts Project grant is to provide funding for organizations directly engaged in the creation of art, the production of artistic performances or arts services, or the sponsorship of quality arts activities in our local communities. This may include dance, literature, media arts, music, theater, visual arts activities, and public art projects. A variety of activities including art and music festivals, community choirs, dance performances, literary readings, instrumental and vocal music concerts, theater productions, visual art classes and exhibitions are eligible.

Due to the current COVID-19 health situation, and cuts to our State Arts funding Prairie Lakes Regional Arts Council will prioritize funding arts organizations so they can survive and adapt. Funds may be used to develop or deliver ways of meaningfully engaging students, participants, or audiences during the pandemic and after. This arts programming may be online or through virtual activities and events.

Prairie Lakes is encouraging arts projects for cultural activities and underserved populations as identified in our PLRAC Diversity, Equity, and Inclusion Statement on page 3 of the newsletter. This includes: BIPOC (Black, Indigenous and People of Color), Economically Disadvantaged, Youth, Senior Citizens, People with Disabilities and LGBTQ+.

Small Arts Project Community Grants have increased to \$4,000 and no cash match is required. We are interested in receiving new applications for arts projects for cultural activities and/or underserved populations. The arts council encourages innovative programming and growth.

- Update: Applicants will now be allowed to receive more than one grant per fiscal year and projects must be completed within one year of the awarding of the grant.
- We request that arts organizations seeking a second grant describe how their activity will expand and reach new audiences and engage the public in new ways by trying to be more inclusive in their programming.

For example, within the context of your community, describe how your project identifies and proactively addresses barriers to engaging historically marginalized, targeted, and underserved people and identities that may otherwise have limited access to your proposed activity. ## Arts Access activities that plan to reach new audiences and engage the public in new ways should also think about Equity and Inclusion.

Within the context of your community, describe how your project identifies and proactively addresses barriers to engaging historically marginalized, targeted, and underserved people and identities that may otherwise have limited access to your proposed activity."

- 1. Explain how your **organization or group** is best positioned to engage with and support the community you have described.

## Prairie Lakes Regional Arts Council is creating their first Equity Taskforce in 2021

At our Prairie Lakes board meeting in November 2020 the council made some minor updates to the PLRAC Diversity, Equity, and Inclusion Statement listed below. They also identified equity and inclusion action steps for the year. One of them is to create our first Equity Taskforce.

The **Equity Taskforce** would be made up of community members who represent an "underserved community", BIPOC, or a Person with a Disability and/or LGBTQ+; and have an interest in building relationships and increasing Arts Access in their community.

The **Equity Taskforce** would meet with the PLRAC Staff and Executive Committee members and provide feedback on our policies, grant guidelines and applications as it pertains to Equity and Inclusion, through a series of Zoom meetings in February and March 2021.

The goal of the taskforce is to meet periodically and make

suggestions on how Prairie Lakes can adjust our systems and processes to break barriers and bridge gaps that underserved communities have in participating with us and our services. A stipend will be paid to taskforce members. Prairie Lakes recognizes we can build increased connectivity and economic strength through supporting cultural and artistic expression of all social identities including race, ethnicity, national origin, age, gender, sexuality, religion, ability, socioeconomic background, and the intersectionality of these identities.

Do you represent an underserved community and have an interest in building relationships and increasing Arts Access in your community? ## Diversity, Equity, and Inclusion Statement of Prairie Lakes Regional Arts Council

Approved April 2019 and updated November 2020.

The Prairie Lakes Regional Arts Council (PLRAC) recognizes arts and culture as inherent and vital aspects of life. Art is a proven proponent of healthy, balanced, and prosperous communities. The creation and experience of cultural and artistic expression contribute to both individual and community well-being. We believe in the ability to build increased connectivity and economic strength through supporting cultural and artistic expression of all social identities including race, tribal affiliation, ethnicity, national origin, age, gender, sexuality, religion, ability, socio-economic background and the intersectionality of these identities.

This may include historically marginalized and underserved groups such as:

- BIPOC (Black, Indigenous and People of Color) including Native American, Black/African/African American, Afro Latino, Caribbean, Chicano/Mexican, Central American, South American, Middle Eastern/North African, Southeast Asian/Asian/Pacific Islander, Immigrants, Refugees, and Muslim individuals.
- · Economically disadvantaged
- Youth and Seniors
- People with Disabilities
- LGBTQ+ (Lesbian, Gay, Bisexual, Transgender, Queer, etc.)

We are committed to closing access gaps in the arts with urgency and accountability. We believe sustained impact requires authentic relationships and transformative work, and to this end we are deeply invested. As stewards of public funds, including those allocated by the Legacy Amendment, PLRAC embraces the unique opportunity to ensure that all residents of the nine-county area have access to quality arts experiences. We celebrate our region as an artistic cultural hub where artists and community members from all walks of life intersect. PLRAC dedicates its work to providing key support at these vital intersections where art and community align. PLRAC is committed to engaging in the relationship building, self-reflection, community discourse, and hands-on work imperative to make our region a place where all artistic communities can thrive.

PLRAC will focus our resources to educate ourselves, modify our practices and shift our own organizational culture to challenge racial disparities as we move toward equitable arts communities. We embrace our responsibility to lead racial equity work in funding, while informing and learning from equity and inclusion in the artistic practices and programming of our constituents.

## State Arts Board Funding is Awarded to Arts Organizations in Region 9

A total of \$220,400 has been Awarded to 17 Arts Organizations from the Prairie Lakes Region by the Minnesota State Arts Board in their Creative Support Grant Program for Organizations this Fall.

Prairie Lakes Regional Arts Council is happy to announce that a total of \$220,400 has been awarded to seventeen



organizations in our region from the Minnesota State Arts Board's Creative Support for Organizations grant program. "I was very pleased to listen to the MSAB meeting on December 2, 2020 to hear which organizations were funded from our region in this program," noted Brenda Byron. It was the second group of grantees in the Creative Support program, and there were two deadlines in the fall.

"When we heard about the new program by the MN State Arts Board, I immediately began sharing the information with our arts organizations", noted Byron. We had already been in contact with arts groups regarding the PLRAC grant deadlines in August, so I was able to encourage our groups to apply, noting that this would be a great opportunity for them to receive up to \$15,000. I am very pleased that individuals from those groups took the extra time to apply for the State Arts Board grant. For this new grant, the application form had been simplified but the quick turnaround time to submit it was an issue for organizations that were just trying to reorganize and survive during this difficult time of COVID-19.

Here is a summary of the arts grantee information PLRAC collected. Eleven groups were awarded \$15,000 and include DalekoArts in New Prague; Dance Conservatory of Southern Minnesota, Mankato; the Fairmont Opera House; Mankato and North Mankato ACT on Alzheimer's for the Singing Hills Chorus; Mankato Area Youth Symphony Orchestra; the Mankato Symphony Orchestra; Martin County Preservation Association, Red Rock Center for the Arts in Fairmont; Merely Players Community Theater of Mankato; Open Arts Minnesota in Mankato; State Street Theater Company in New Ulm; and Twin Rivers Council for the Arts in Mankato. The Mankato Ballet Company received \$13,100, the Arts Center of Saint Peter received \$12,000, and Project GEM of Pemberton received \$10,000. The

Summit Avenue Music Series in New Ulm received \$8,000, The Grand Center for Arts and Culture in New Ulm received \$7,300, and the Deep Valley Book Festival of Mankato received \$5,000. These grants were awarded in October and December of 2020.

Four additional organizations have applied for a \$15,000 Creative Support for Organizations grant and will find out if they received it in March of 2021. These organizations include Davori Productions, Mankato Playhouse; the La Grande Bande music group from Gaylord; Mankato Children's Chorus; and the Waseca Arts Council. We are hopeful that these organizations will also be funded.

These additional State funds from the MN State Arts Board awarded into the 9-county region that Prairie Lakes serves, is wonderful! It will tremendously help our arts organizations at this difficult time and provide more resources. Prairie Lakes is limited in the State Arts funding that we receive annually, and it is based primarily on the population in our region. Therefore, larger regions that include larger cities like Duluth, Minneapolis/St. Paul, Rochester and St. Cloud receive a lot more funding than our region. In our last fiscal year, FY 2020, Prairie Lakes awarded \$163,500 in grants to twenty-five organizations in the fall. In the spring we awarded \$117,050 to twenty organizations, which totaled \$280,550 to forty-five organizations. Also, last year in FY 2020 we awarded forty-six grants in the Small Arts grant program to arts and community groups, and schools totaling \$83,379 from our State funds.

So, in FY 2020 we funded 91 organizations to produce or sponsor a variety of arts activities (July 1, 2019 to June 30, 2020). Prairie Lakes anticipates awarding a slightly smaller amount of arts grants and money in FY 2021, since we received a 14% cut in our Arts and Cultural Heritage funding. Also, several arts organizations are carrying over their FY 2020 Arts and Cultural Heritage grant and arts programming into FY 2021, which is spring/summer 2021 when it may be safe to gather people together again for an arts performance or activity; and therefore, may not be applying for another grant this year.

# Prairie Lakes Provides Overview on how the COVID-19 shut down has affected Art Centers and Arts Organizations - March to Dec. 2020

As you may know, many arts organizations closed their doors for several weeks due to COVID-19 in March -April 2020. Their staff and boards had to meet and decide how they could survive under these circumstances. They needed to determine if they had the capability to do their programming virtually, since it was not safe to do inperson arts events. Prairie Lakes contacted organizations and offered to help and discuss the transition arts groups could make through a few Zoom meetings. This assisted groups in knowing that they were not alone in this situation, and other arts groups in the nine-county area could learn from each other. There was discussion on how arts organizations can pivot or transition to do their arts programming differently and learn how to do digital programming and virtual arts activities. Several art centers were able to discuss how they planned to do online virtual programming, and start to showcase their monthly arts exhibitions by posting photos on their website or Facebook page, to stay connected with their arts audience and the public.

Arts organizations that own a building are in the most vulnerable position since they have monthly expenses whether the building is open or not for their arts programming. The loss of revenue to arts organizations has been devastating! There is a continuing concern that we don't know what percentage of people will be comfortable attending in-person activities due to the pandemic, so future ticket sales for theater and music performances, and buying art at a local art center may be a lot less.

How Has Prairie Lakes Been Able to Assist Arts Organizations? Prairie Lakes has been assisting arts organizations by continuing our arts grant programs this fall. Our grant programs remain very similar to past years but now include questions about how arts groups will adapt to COVID-19 restrictions. Prairie Lakes has received a 15% cut in State Arts and Cultural Heritage (ACH) funding through the MN State Arts Board, and we have received approximately thirty-nine percent of our funding for the fiscal year. The State funds are being received and awarded incrementally, since our State funding is being provided to us in installments over several months.

<u>It has been important for Prairie Lakes to get the funds</u> out the door in grants as soon as possible to assist our arts

organizations who are in a difficult situation. The funding will help organizations survive and adapt at this time to cope with COVID-19 issues. We awarded ACH grants in August, September and October based on funds we currently have. These State funds are from the Clean Water, Land and Legacy Amendment.

In August, we awarded eight arts organizations Arts and Cultural Heritage (ACH) grants totaling \$83,000. In September we awarded nine arts organizations an ACH Arts grant totaling \$54,000; and in October we awarded three arts organizations an ACH Arts grant totaling \$17,130; for a cumulative total of \$154,130. Due to COVID-19 all organizations that received a grant from PLRAC must plan for events that include social distancing and wearing masks; and they are required to follow the Governor's Stay Safe Plan and the MN Department of Health's recommendations.

The Arts grants that PLRAC provided are for arts activities in all artistic disciplines. About 50% of these arts activities will be virtual events and 50% in-person events. The virtual events may include art and literature classes, literary festival, visual art festival, art exhibitions shown virtually, music rehearsals for choirs done through Zoom, or joint music performances conducted through Zoom or another online platform. Small Theater performances and Instrumental music concerts have been videotaped and then shown online through YouTube, or other platforms. In-person events are planned for theater performances, art classes with limited capacity, Art exhibitions where people socially distance within the space, etc. Several arts groups are waiting until Spring 2021 to decide if their programming will need to be done virtually or if they can start to do in-person arts events.

### Arts and Cultural Heritage Grants of \$154,130 Awarded to Twenty Area Organizations

The Prairie Lakes Regional Arts Council is pleased to announce that Arts and Cultural Heritage (ACH) grants of \$154,130 were awarded to twenty arts organizations in the fall of 2020.

This fund was created by the people of Minnesota to support the arts and preserve our heritage. The Clean Water, Land and Legacy Amendment, passed by the voters in Nov. 2008, created new resources for land conservation, water conservation, parks and the Arts. The next ACH Grant deadline is February 1, 2021. Organizations can apply once per year for this grant. Due to COVID-19 all organizations must plan for events that include social distancing and wearing masks; and they are required to follow the Governor's Stay Safe Plan and the MN Department of Health's recommendations.

The organizations are listed alphabetically. The grants are for **virtual events** and in-person arts activities in all artistic disciplines.

## What's new with the FY 2021 Arts and Cultural Heritage Grant?

There are a few changes to the Arts and Cultural Heritage (ACH) Grant program this year, due to the current health situation, and cuts to our State Arts funding. Prairie Lakes Regional Arts Council will fund projects from non-profit tax-exempt 501c3 arts organizations or an arts group using a fiscal sponsor that is producing an arts activity in dance, literature, media arts, music, theater, and visual art are eligible.

We are especially interested in funding arts projects that include historically marginalized and underserved groups such as: BIPOC (Black, Indigenous, and People of Color), Economically Disadvantaged, Youth and Seniors, LGBTQ+ and People with Disabilities.

## Our priority for the coming year will be to help arts organizations survive and adapt.

- Due to COVID-19 applicants must <u>plan for events that include "social distancing"</u> and you are required to follow the Governor's Stay Safe Plan and the Minnesota Department of Health's recommendations. Applicants must submit a Reopening and COVID-19 plan.
- No projects or arts activities can take place that risk the health of the participants or audience.

ACH Large Arts Organization Stability Grant, maximum \$11,000. Deadline: February 1, 2021. Eligibility: They must be a 501c3 Arts Organization that has year-round arts programming, has paid staff, and owns their building (or have a yearly lease); and was the recipient of a PLRAC ACH grant in FY 2020.

### ACH Arts Project Grant, maximum \$6,000. Deadline: February 1, 2021.

<u>Use of funds</u>: Arts programming may be online or through virtual activities and events, and in-person if following Minnesota Department of Health's recommendations. Expenses may include artist fees, salaries, publicity, equipment/technology, training, monthly rent and utilities.

#### ACH Arts & Music Festivals Grant. Maximum \$4,000.

Deadline: **February 1, 2021.** For non-profit tax-exempt 501c3 arts organizations that are sponsoring arts/music festivals and activities that represent diverse ethnic and cultural arts traditions.

## 108 Area Students were Awarded Youth Art Scholarships for a total of \$27,300

The Prairie Lakes Regional Arts Council is pleased to announce that scholarships of \$27,300 from the Arts and Cultural Heritage Fund, which is funded by the Clean Water, Land & Legacy Amendment, have been awarded to 57 students in grades 7-12 and 51 students in grades 3-6 throughout the region. Students in grades 7-12 receive \$300 and grades 3-6 receive \$200. The Youth Scholarships will provide these students the opportunity to study their chosen art with a practicing professional artist by taking lessons over a period of months. A variety of lessons in cello, dance, guitar, organ, piano, percussion, string bass, theater, trumpet, viola, violin, and visual art will be provided.

"Youth Scholarship recipients live in twenty-three different communities representing seven counties," noted Brenda Byron, PLRAC Executive Director. "We are excited about the wonderful arts activities these students will be involved in." They will be taking lessons and participating with many area arts groups including: BlueJay Dance Studio in Waseca, Dance Conservatory of Southern MN in Mankato, Mankato Ballet Company, and Spotlight Dance Company in Mankato; music lessons at Gustavus Adolphus College

Piano Lab School, Mankato School of Music, and New Ulm Suzuki School of Music; visual art lessons at Waseca Art Center; participation in Mankato Area 77 Lancers Marching Band, and Mankato Playhouse. Many independent music and art instructors throughout the area will also be providing lessons for these students.

The \$300 Youth Scholarship Recipients from grades 7-12 live in twelve different communities representing six counties. The \$200 Youth Scholarship Recipients from grades 3-6 live in eighteen different communities representing seven counties. Refer to page 9 for complete lists of students by County.

<u>Thinking about applying?</u> Students should remember to answer their application questions with several sentences in a paragraph answer. In general, students scored higher in the review process if they provided more detailed answers to the questions.

- Students in grades 7-12 must be participating with an instructor, an organization or arts discipline for at least 2 years to be eligible.
- Students in grades 3-6 must be participating for at least one year to be eligible.
- Both age groups require an online **Letter of Recommendation** from a teacher as part of their application. It should describe goals and outcomes for the students learning during the time period of the scholarship, which may cover several months.

#### Youth Scholarships, Grades 7-12, listed by County and Community

A total of \$17,100 was awarded to 57 students for scholarships of \$300 each; and they live in 12 different communities, representing six counties.

#### Blue Earth County - \$4,500

We would be happy to assist you. We are committed to assisting artists and arts organizations in our region as we respond to the COVID-19 health situation.

We encourage any grantee that has had to change plans because of COVID-19 to contact us to talk about changing the details of their grant to allow them more flexibility in how they use the funds. We plan to be as flexible as possible in this regard. We understand that some events have been cancelled and we will work with any grantee to find appropriate solutions.

Governor Walz is continuing the Stay Safe order. Arts groups should anticipate that the "social distancing" guidelines will continue and this may impact your arts activities, and your planning.

Regardless of the venue or gathering, all staff and participants should maintain social distancing of at least 6 feet between households, cover coughs and sneezes, wash hands often, and stay home if sick. Face coverings are required whenever one is gathering or in a setting with others from outside their household.

Face coverings help slow the spread of COVID-19 by helping to keep the person wearing the covering from infecting others. Evidence suggests that the virus causing COVID-19 can be spread by droplets released from the nose and throat of an infected person when they cough, sneeze, sing, speak, or breathe, even if the infected person is not showing symptoms.

#### FY 2021 Arts and Cultural Heritage Grant

Deadlines are: Aug. 1, Sept. 1 and Feb. 1

Due to the current COVID-19 health situation, and anticipated cuts to our State Arts funding Prairie Lakes Regional Arts Council will fund projects from non-profit tax-exempt 501c3 arts organizations or those using a fiscal sponsor that are sponsoring an arts activity in dance, literature, media arts, music, theater and visual arts. Our priority for the coming year will be to help arts organizations survive and adapt.

ACH Large Arts Organization Stability Grant. Arts Programming/Access – maximum \$11,000. Deadline: August 1, 2020 and February 1, 2021. No specific cash match is required. Eligibility: They must be a 501c3 Arts Organization that has year-round arts programming, has paid staff, and owns their building (or have a yearly lease); and was the recipient of a PLRAC ACH grant in FY 2020.

ACH Arts Project Grant. Arts Programming/Access – maximum request \$6,000. Deadline: September 1, 2020 and February 1, 2021. No specific cash match is required.


<u>Use of funds</u>: Arts programming may be online or through virtual activities and events, and in-person if following Minnesota Department of Health's recommendations. Expenses may include artist fees, salaries, equipment/technology, training, promotion, monthly rent (lease payments) and utilities.

ACH Arts & Music Festivals Grant. Maximum request \$4,000. Deadline: September 1, 2020 and February 1, 2021. For non-profit tax-exempt 501c3 arts organizations that are sponsoring arts/music festivals and activities that represent diverse ethnic and cultural arts traditions.

#### **ACH Youth Scholarship:**

Youth Scholarship for Students (7-12) – \$300, and grades (3-6) - \$200. Students have the opportunity to study their chosen art with a practicing professional artist by taking lessons over a period of months. This is for all Art disciplines. Deadline for grades 7-12 is October 1; and grades 3-6 is November 1.





#### **Small Arts Project Community Grant**

Non-profit arts organizations, community groups, or public organizations producing or sponsoring arts activities for their community are eligible. Grants may be \$4,000. Fundable activities include: arts and music festivals, community bands and choirs, theatre events, dance activities, literary readings, visual arts exhibitions and classes, etc. Deadline: August 1, and the 1st of each month until May 2021.

#### **School Arts Project Grant**

Grants are for schools K-12 public and private. Matching grants up to \$2,000 are available to fund Artist residencies, live art performances, miniworkshops or arts related field trips. Cash match is 10%. Deadline: August 1, and the 1st of each month until May 2021.

#### **Artist Development Grant**

This project grant provides financial support to artists committed to advancing their work and careers. The artist grant of \$1,500 is more flexible this year and it can be used to sustain artists during this difficult time of the COVID-19 pandemic. Up to 100% of the funds can be used for artist creative time and/or living expenses if needed

Deadline: June 1, 2020

Earliest start date: August 1, 2020

The applicant or organization must have an address and provide arts programming within the Prairie Lakes region; the counties are: Blue Earth, Brown, Faribault, LeSueur, Martin, Nicollet, Sibley, Waseca, or Watonwan County.

## Learning about Diversity, Equity, and Inclusion in the Arts

For the past two years Brenda Byron, the Prairie Lakes Executive Director has been attending meetings and workshops on the topic of **diversity**, **equity**, **and inclusion** in the Arts. This effort is also in collaboration with the eleven Regional Arts Councils in Minnesota that will focus on Intercultural Competence in FY 2021. Six meetings of the Regional Arts Council (RAC) Director's were held in 2018-2019 with a consultant that led the RAC's through this discussion. It included an individual assessment survey completed by all Directors focusing on their "intercultural competence" through survey questions and several learning sessions.

Byron noted that "It's been very interesting to explore tactical ways boards and leadership can expand our understanding of diversity, inclusion and equity and build it into our organizational culture and decision making. All information has been shared with the Prairie Lakes Board. It was important to learn some definitions in this area and to bring back the information to our Prairie Lakes board at several meetings." This information may also be helpful to the arts organizations and community groups we serve in the nine-county area."

"Although we may have a small percentage of racial diversity in our region, it is still important to be aware of including all people in the Arts, noted Byron. In our nine county region the White population is about 90% or higher in 8 counties and our 9th county Watonwan has 77% White, 20% Hispanic, and 3% other. "The goal of PLRAC as an organization in FY 2021 is to strive for Equity and Inclusion in our policies, programs and the communities we serve."

Therefore, a few new questions are being asked about Equity and Inclusion in our grant applications if an organization's project is to provide Access to the event. These questions encourage applicants to think broadly and plan intentionally to reach more people through their arts programming and activities. Arts Access activities that plan to reach new audiences and engage the public in new ways, should also think about Equity and Inclusion.



Within the context of your community, describe how your project identifies and proactively addresses barriers to engaging historically marginalized, targeted, and underserved people and identities that may otherwise have limited access to your proposed activity.

Examples might include:

- \* BIPOC (Black, Indigenous and People of Color) including Native American, Black/African/African American, Afro Latino, Caribbean, Chicano/Mexican, Central American, South American, Middle Eastern/North African, Southeast Asian/Asian/Pacific Islander, Immigrants, Refugees, and Muslim individuals.
- \* Economically disadvantaged
- \* Youth and Seniors
- \* People with Disabilities
- \* LGBTQ+ (Lesbian, Gay, Bisexual, Transgender, Queer, etc.)

Here are a few definitions we'd like to share to inform you about this topic.

<u>Diversity.</u> The presence of difference within a given setting. Include race, gender, ethnicity, religion, nationality, sexual orientation, language, socio-economic status, ability, geographical location and more.

<u>Culture</u>. A culture is a way of life of a group of people: the behaviors, beliefs, values, and symbols that they accept, generally without thinking about them, and that are passed along by communication and imitation from one generation to the next. "The way we do things around here."

<u>Cultural difference.</u> The fact of human difference that makes a difference in how we interact with one another.

**Equity.** Promote justice, impartiality and fairness within the procedures, processes and distribution of resources by institutions or systems. Eliminate root causes of outcome disparities within institutional and societal systems.

<u>Inclusion</u>. Individuals with different identities feeling and/or being valued, leveraged, and welcomed to fully participate within a given setting.

<u>Intercultural Competence</u>. The capability to shift cultural perspective and appropriately adapt behavior to cultural difference and commonalities.

<u>Competence.</u> Cultural self-awareness including around power and privilege. Recognize overemphasis on commonalities. Increase understanding of cultural differences and understanding of cultural-general frameworks. Interact across cultural difference in ways that expand cultural understanding. Continue to build on knowledge of cultural difference and further develop skills to adapt across differences.
